### **Hereby Decides**

#### **Article 1**

This Prakas aims at implementing the guideline on the below 10-hectare small scale ecotourism development projects in Cambodian natural protected areas and biodiversity conservation corridors.

#### **Article 2**

Ministry Cabinet Chief, all Director Generals of all General Directorates, Inspector Generals, Department of Internal Audit, Department of Environmental Impact Assessment, and all Directors and Chiefs of all units under the umbrella of the Ministry of Environment shall collaborate and implement this Prakas effectively from the date of signature.
